Land Running S. 50. W. 9 to a stake S. 20. E. 20. 75 to post oak S. 75. W. 89 Stake
to red oak then N. 55. W. 17 to pine Stump then S 30 W 13 to post oak then North
63. W. 17. 50 to Spanish oak near # blacks then N. 20. E. 45 to a pine on Sanderman
line then along Sandermans line to red oak on Berups line to post oak then
to the beginning Including one hundred and Seventeen acres together with
all and singular the rights members Heredeterments and appertaining
to the Said premises belonging or in any wise Incident or appertaining
to have and to hold all and singular the premises before mentioned unto
the Said George Spillars and I do hereby bind myself my heirs Executors
