of Sundry writs of fieri Facias issued out of the Court of Common
Pleas held for the district of Greenville tested the Second day of
April in the year of our Lord one thousand eight hundred and
thirty three at the Suit of M^r. Lewis and James Gidley to me di-
rected commanding me that of the goods and Chattels Lands
and tenements of Willis Wells to Levy the Sum of Eighty Eight
dollars 79/100 Damages and costs I have seized and taken of the
Lands and tenements of the Said Willis Wells all that certain
piece parcel and tract of Land containing Eighty acres be the Same
more or less situate and being in the district of Greenville on the
waters of Brush Creek adjoining Lands of William Jacobs Willis
Benson & B. S. Earle being the Same that the Said Willis Wells lived on

mentioned have been exposed to Sale at Public Vendue and purchased
by William Jacobs of the district aforesaid for the Sum of one
