 the State and District aforementioned of the other part Witnesseth that
 Alexander McKennie for the Inconsideration of the Sum of five thou-
 sand dollars in hand paid me by Joseph McKennie the receipt is
 hereby acknowledged hath Bargained Sold and Delivered and do
 by these presents Bargain Sell and Deliver unto Joseph McKennie two
 certain tracts or parcels of land containing as follows the first
 tract two hundred and fifty acres more or less Situate in Greenville
 District aforesaid on both Sides of the South fork of Tyger River it
 being Land granted to John Collins the twenty first day of January
 1785 Beginning on one oak on the North Side of the South fork of
 Tyger there due N. 32 E to a post oak thence S. 44. W. 58. Cts 50 lines
 to one oak thence S. 15. E. 36 Cts to oak thence S. 68. E. 17 Cts to red oak
 thence to the Beginning out said tract is to be excepted a small part sold to Hott
 Goodlett of the North corner also fifty acres of land joining the above taken
 of a tract of land granted to Thomas Lowry the 26th day of April 1786 mak-
 -ing in the whole two hundred and fifty five acres excepting the part
 sold Goodlett as aforesaid also an other tract or parcel of land con-
 -taining as follows one hundred and fifty acres more or less it being
 part of a tract of land containing two hundred acres of land granted
 to Thomas Lowry by his Excellency William Moultrie on the 26th day of
 April 1786 having such Shapes forms Marks and boundaries as appears
 by the plat to the said Grant lying and being in the State and
 District aforesaid on the middle fork of marsh Creek waters of South
 Tyger River Beginning on a hickory thence S. 45. E. 48. 50 to a stake thence
 S. W. to a post oak thence N. 20. E. 34. 60 thence N. E to the Beginning corner
 including both tracts or parcels of land containing in the whole four
 hundred and five acres more or less together with all and singular
 the Woods Water and Water Courses Proffits Priviledges Hereafterments
 and appertainances and whatsoever belonging to the aforesaid
 premises I the said Alexander McKennie do warrant and forever defend
 the two aforesaid premises unto the said Joseph McKennie and his heirs
 forever from myself my heirs and all other person or persons lawfully
 claiming the same or any part thereof In Witness I have hereunto set
