South Carolina } Know all men by these presents that I Peter Soter of the State Greenville District } and district aforesaid for and Inconsideration of hundred dollars to me in hand paid by Henry Pike of the State and district aforesaid have Granted bargained Sold and released and by these presents do Grant bargain sell and release unto the Said Henry Pike one hundred acres of Land lying and being in the State and district aforesaid on the main Branch Creek the Waters of Enoree River begining on a sweet Gum on the bank of Said Creek running East to a stake Joining rains line thence running North West to a black oak on the public road that leads from Greenville to Spartanburgh thence along Said Road to Jefe Hawkins Corner on a post oak thence running with Hawkins line North course to a post oak corner thence West to a post oak corner thence on Said Davis line to a black oak corner in the fork of the Branch thence down the Said Branch to the main Branch Creek thence Down Said Creek to the begining all that herein described the premises together with all and singular the rights members Hereditaments and appertainances to the Said premises belonging or in any wise Incident or appertaining to have and to hold all and singular the premises before mentioned unto the Said Henry Pike his heirs and assigns forever and I do hereby bind myself my heirs and Executors and Administrators to Warrant and forever defend all and singular the Said premises unto the Said Henry Pike his heirs and assigns against myself my heirs and against Every person whomsoever lawfully claiming or to claim the Same or any part thereof in Witness whereof I have hereunto set my hand and seal this the fifth day of November 1819
