of our Lord one thousand Eight hundred and thirteen between  
Abraham Huntsucker of the State of Virginia Washington  
County of the one part and David Blythe of the State of South  
Carolina and Greenville County of the other part witnesseth  
that he the said Abraham Huntsucker for an inconsidera-  
tion of the sum of one hundred dollars to him in hand paid  
by the said David Blythe hath bargained and sold and  
by then presents doth bargain sell make over and confirm  
unto the said David Blythe his heirs and assigns one certu-  
-in tract or parcel of land containing twenty five acres  
more or less it being part of a tract granted to John Wallis  
said land situate in the State of South Carolina and  
district of Greenville on the North Side of the Saluda  
Beginning at mouth of the Branch a conditional line between  
Thomas Blythe and Huntsucker thence up the said branch  
to the line of said Grant thence down the line of Grant to  
the River thence up the said river to the Beginning and hath  
Such Hopes and marks as a plat annexed to sd Grant repre-  
sents and certify for John Wallis to have and to hold said  
Land premises him his heirs and assigns against the said  
Abraham Huntsucker his heirs or assigns which the said Abra-  
-ham Huntsucker for himself his heirs and assigns or any other  
person will warrant and forever Defend the title of the said  
Land to the said David Blythe his heirs and assigns in witness  
whereof he the said Abraham Huntsucker hath hereunto set  
his hand and fixt his seal the day and date first above written
