 thence S. 71 W. 19.25 lbs Stake thence N. 20 W. 17 chs to a stake thence
 S. 70 W. 12.25 lbs to a stake thence S. 21 E. 12 chs to a small pine
 thence S. 40 E. 11.50 to a stake thence S. 48 E. 20 chs to a turkey oak
 on the River then along the Meander of said river to a flat
 Rock thence N. 67 E. 43.50 lbs to the Beginning containing one
 hundred and seventy five acres be the same more or less
 for the sum of six hundred and ninety dollars to me paid
 by James Thompson of the State and district to have and
 to hold all and singular the premises as above mentioned
 unto the said James Thompson his heirs and assigns
 forever together with all and singular the rights mem-
 bers here determined and appertainances to the said
