Have granted, conveyed, sold, and released, and by these presents do grant convey, sell and release, unto the said W<sup>m</sup> Choice Jr. of Greenville and State of South Carolina all that tract of lands lying in the District of Greenville and State of South Carolina on the waters of Long Branch Beginning at a stake and running N 35 E 28.60 to W<sup>m</sup> Cleland's line & thence N 44 W to Chestnut stump three 1/2 30 E 1/2 Chains to a red Oak near the white horse road and thence S 52 East 26 3/4 the beginning corner containing two hundred and seventene acres more or less and bounded by the lands of J. Cleland Hon. Genl A. Pinnett Samuel M. Chastan Edmond Maddell and being lands that I bought at the sale of J. H. Goodlett's real Estate Together with all and singular the right member, covenants, and appurtenances to the said premises belonging or in any wise incident or appertaining To have and to hold all and singular, the premises before mentioned unto the said William Choice Jr. his heirs and assigns for ever

And I do hereby bind myself my heirs Executors and Administrators to warrant and forever defend, all and singular the said Premises, unto the said William Choice his heirs and assigns against myself my heirs and against every person whomsoever, lawfully claiming or to claim the same or any part thereof
