 of Wilks am held and firmly bound unto Peter Cauble or assigns the
 Last and full sum of three hundred and ninety four Dollars and ninety
 Cents good and lawful money, when ever default is made in the under
 written Condition I bind myself my heirs Executors & administrators
 Jointly & severally by these presents sealed with my seal and dated this
 24th July 1837. The Condition of the above obligation is such
 that if the said Robert Vickers shall do well and truly pay the
 said Peter Cauble the amt of One Hundred & ninety seven Dollars and forty
 five Cents with Interest from this date which will more fully appear by
 a Note of hand for the last mentioned amt which Note bears date
 with this article then this obligation together with the note is to be
 void or else remain in force and virtue the express understanding and
 agreement is that should I neglect or refuse to pay the said Cauble
 the amt last mentioned that he Cauble is hereby authorized and empower-
 ed to retain the same with interest out of my part of the real estate
 coming to me from the Estate of my father the Interest consists in the House
 & Lot now occupied by Bro Watson nevertheless this article is not intended to
 postpone or delay the sale of said Lot & I hereby authorize the said Cauble
 to sell the same by giving publick notice in the usual way with proper
