State of South Carolina } This Indenture made the fifth day of August 1839
 Greenville District } in the Year of our Lord one thousand eight hun-
 dred and thirty nine between Peter Cauble Executor of the Estate of Alex-
 ander Vickers deceased and William Blasingame all of the District in the
 State aforesaid whereas Robert Vickers heir & Legatee of the Estate aforesaid
 did authorize the said Peter Cauble Executor as aforesaid by an instrument
 of writing under seal which is hereunto annexed and intended to be made
 a part of this deed to advertise and sell all his Robert Vickers undivided
 interest or distributive share of the House and lot lying and being in the
 Village of Greenville on the Main Street marked in the Chart or plan of the
 Village N^o. adjoining lands of William Turpin Theron Earle & others
 being the same whereon James M. Claughlin & Richard Burnham now live.

Whereupon I the said Peter Cauble did advertise his Robert
 Vickers undivided interest or distributive share being tenth part of said
 House & Lot for sale on the first Monday in August 1839 - And caused
 the sheriff aforesaid to sell the same at Publick outcry - And whereas the
 sheriff aforesaid did on the day aforesaid expose to sale before the Court House
 door at publick outcry for cash the said undivided interest when the said
 William Blasingame was the last and highest bidder to whom the said
 land was struck off for the sum of One hundred dollars -

Now this Indenture Witnesseth that in consideration of the sum
 of One Hundred dollars to me paid by the Authority aforesaid. I have granted
 bargained sold and released and by these presents do grant bargain sell and
 release unto the said William Blasingame his heirs & assigns forever from
 myself my heirs & from all other persons or persons lawfully claiming or to
 claim - In witness whereof I have hereunto set my hand and affixed
 my seal the day and Year above written - Signed sealed and delivered
 in presence of Chas J. Holcombe H. McKenzie } Peter Cauble. Escal.
