South Carolina } This Indenture, made the twelfth day of October in the Greenville District } Year of Our Lord one thousand eight hundred and thirty nine between Mary W Lewis of the one part, and Schaboa Hawkins of the other part Witnesseth - Whereas, the said Schaboa Hawkins stands indebted to the said Mary W Lewis in the sum of six hundred & sixty six Dollars by promissory note bearing date the day of the presents and due and payable the eighteenth day of June Eighteen hundred & forty - Now this Indenture witnesseth, that the said Schaboa Hawkins for and in consideration of the said Debt or sum payable as aforesaid to the said Mary W Lewis and for the better securing the payment thereof to the said Mary W Lewis according to the tenor and effect of the promissory note aforesaid and also in consideration of the sum of one dollar to the said Schaboa Hawkins by her the said Mary W Lewis in hand paid at and before the sealing and Delivery of this presents doth grant, bargain sell, alien, release, convey and confirm unto the said Mary W Lewis and to her heirs and assigns forever a certain tract or parcel of land whereon the said Hawkins now lives containing by measurement one hundred and eleven acres beginning on a stone + 111 at the lower end of a ditch (M B Machow corner on Jeremiah Cleaveland's line thence along S^d line S^o 59 E 20 chs to a post oak + 111 thence N^o 75 E 3 chs 10 lts to a hickory thence S^o 74 E 23 chs to a hickory bush thence N^o 11 E 30 chs 50 lts to a cherry + 111 thence N^o 70 W
