 running through a field thence up said branch to the Spring coming
 on a Stake on the Original line thence to a Stake Nellys Corner
 thence to a Stake on the Original line near Sen Langstons. Thence to a Spa-
 nish Oak bush Caufords Corner thence N 61 E 12.40 to a Black Oak thence
 S 21 E 53 to a Stake two chains east of a Pine Stump an Original corner
