aforesaid on both sides of Jamison's Mill Creek and bounded  
as follows Beginning on a white oak on the North bank of said  
Creek running thence N 48 W 13 chs to a red oak 3x thence N 35 W  
15 chs to a red oak thence S 5 W 30 chs 50 links to a stake on James  
Cockrums back line thence S 15 E 4 chms 50 links to a large Chestnut  
thence a N.E. course to a small Red Oak James Cockrums old line thence  
along said line S 75 E to a sweet gum a conditional corner on Gentry's  
old line thence along said line to Caswell Barretts line thence along  
said Barretts line to the beginning containing one hundred acres be the  
same more or less - To have and To Hold the above granted premises  
unto him the said William Durham his Heirs and Assigns forever  
Together with all and singular the Rights, Members, Hereditaments  
and appurtenances thereto belonging or in anywise incident or  
appertaining; And I the said Harren B Durham do hereby bind  
myself my heirs Executors Administrators and Assigns forever to warrant  
and defend the above granted premises unto him the said William  
Durham his heirs and assigns against myself my heirs and assigns  
and against every other person or persons lawfully claiming or to claim
