Greenville District State and District aforesaid for an inconsideration of one
hundred dollars to me paid by H. B. Allen. I do grant bargain sell and release unto the said
H. B. Allen a certain tract of land in the State and District aforesaid on the head
waters of Mouth Creek being a part of a tract of land granted to John Nicoll
as follows viz Beginning on a known point on the Original line thence running
with Mary Allens. line to a Red Oak Corner thence an said line till it crosses the
Creek and passes the head of a small branch to a Stake Corner, thence due West
to a Red Oak, thence a straight line to the beginning corner, containing fifty
acres more or less. Together with all and Singular the rights members Hereditam-
ents and appertaining to the said premises to have and to hold all and Singular
the premises before mentioned, unto the said H. B. Allen his heirs and assigns
and I do hereby bind myself my heirs Executors and Administrators to warrant
and forever defend all and Singular the said premises unto the said H. B. Allen his
heirs and assigns against myself my heirs and every other person whomsoever
lawfully claiming or to claim the same or any part thereof October 18th 1841.
