I, William A. McDaniel Sheriff of Greenville District and State of South Carolina do hereby certify that by virtue of a writ of Fieri Facias issued out of the Court of Common Pleas in the District of Greenville tested the Twelfth day of March in the year of our Lord one thousand eight hundred and fifty two at the said James McMathew to me directed commanding me that of the goods and chattels lands and tenements of S. W. West to levy the sum of One hundred thirty nine dollars damages and costs I have seized and taken of the lands and tenements of the said S. W. West all that certain parcel and tract of land containing Three hundred thirty one and a half acres and being in the District of Greenville adjoining lands of C. East James Mest S. W. Harris and C. Barton

And whereas the said premises with their appurtenances since the seizure by me made by virtue of the said writ of Fieri Facias have been exposed to sale at public vendue and purchased by Jas McMathew of Greenville District for the sum of one hundred dollars that being the highest sum that was bid therefor Now know ye that I, W. A. McDaniel Sheriff of said District by virtue of the said writ of Fieri Facias to me directed and delivered as aforesaid and by virtue of the statute in such case made and provided and for as in consideration of the said sum of One hundred dollars to me in hand paid and secured to be paid by the said James McMathew the receipt and payment whereof I do hereby acknowledge have granted bargained and sold and by these presents do grant bargain and sell unto the said James McMathew his heirs and assigns forever the several pieces and parcels of land with its appurtenances and all the estate right title and interest which the said S. W. West of right had of us and to the same

To have and to hold the said piece parcel and tract of land with its appurtenances unto the said Jas McMathew his heirs and assigns forever lawfully and absolutely as if the said W. A. McDaniel might and lawfully could do or ought to grant bargain and sell the same by virtue of the Statute in that behalf made and the said writ of Fieri Facias as aforesaid
