hundred and fifty five between Samuel A Jones Esquire Commissioner

 Whereas W^c S^r Alford and others on or about the 24th day of March in
 the year of our Lord one thousand eight hundred and fifty five exhibit their
 Bill of Complaint in the Court of Equity at Greenville South Carolina in

 tition of the Real Estate No. One the cause being at issue before the Honorable
 Court came on to be heard at Chambers 3rd day of April in the year of

 paid him by the said Robert McRay the receipt whereof is hereby acknow-
 ledged Grant Granted Bargained Sold and Released and by three Parts
 with Grant Bargain Sell and release unto the said Robert McRay his
 heirs and assigns all that Tract parcel and lot of Land situate and
 described as follows Beginning at a Post oak corner on the west side
 of the Duncombe road running thence N 44 E 1/2 ch to a small Red corner
 thence South 86 E 6 ch to a 400 corner, thence S 40 E 3 ch 50 L to a 400
 corner, then commencing again at the Beginning corner and running thence
 S 35 E 8 chains and 30 links to a stake being the corner of George Wolfe land
 thence N 44 E 2 1/2 ch and 40 L to the beginning of said 400 corner bounded
 on the North by lands of Edward Croft and David Long on the East by lands
 of Major Lynch on the South by lot of Robert McRay and the Duncombe
 Road on the West by lands of Edward Croft the above lands is exclusive
