 To Richardson Land For To all To whom these presents
 Sheriff of Greenville District
 and State aforesaid send greeting, Whereas by virtue of
 a writ of Fieri Facias issued out of the Court of common
 Pleas held for the District of Greenville tested the Eleventh
 day of February in the year of our Lord one thousand
 eight hundred and sixty at the suit of R. B. Duncan
 assignee, to me directed commanding me that of the
 goods and chattels lands and tenements of Thomas B.
 Cox to levy the sum of One hundred and seventy
 nine dollars & 49/100 Damages and cost I have seized
 and taken of the lands and tenements of the said
 Thomas B. Cox all that certain piece parcel and
 tract of land containing One Hundred, more or less
 acres Situate and being in the District of Greenville
 adjoining lands of J. K. Stone J. Richardson and others
 and whereas the said premises with their appurtenances
 since the seizure by me made by virtue of the said writ
 of Fieri Facias before mentioned have been exposed to
 public vendue and purchased by Jonathan
 Richardson of the District of Greenville for the sum of
 Four Hundred and sixty six dollars being the highest sum
 that was bidden therefor. Now know ye that I J. S. McDaniel Sher-
 iff aforesaid by virtue of the said writ of Fieri Facias aforesaid
 to me directed and delivered as aforesaid and by virtue of the
 Statute in such case made and provided and for and in con-
 sideration of the sum of Four Hundred and sixty six dollars
 to me in hand paid, or secured to be paid by the said Jonathan
 Richardson the receipt and payment whereof I do hereby acknow-
 ledge have granted bargained and sold and by these pres-
 ents do grant bargain and sell unto the said Jonathan Richardson
 heirs and assigns forever the said tract piece and parcel of
 land with its appurtenances, and all the estate right title and
 interest which the said Thomas B. Cox of right had of in and
 to the same, To have and to hold the said piece parcel and
 tract of land with its appurtenances unto the said Jonathan
 Richardson heirs and assigns forever as fully and absolutely
 as I the said J. S. McDaniel might could or ought to grant
 bargain and sell the same by virtue of the Statute aforesaid
 and the said writ of Fieri Facias or otherwise
 In witness whereof I the said J. S. McDaniel have hereunto
 set my hand and seal the fourth day of October in
 the year of our Lord one thousand eight hundred
 and sixty, sealed signed and delivered in the presence
