 Virtue of a writ of Fieri Facias issued out of the Court of Common
 Pleas held for the District of Greenville Tested the twenty ninth
 day of October in the year of our Lord one thousand eight
 hundred and sixty at the suit of John Middle to me directed
 commanding me that of the goods and chattels lands and
 tenements of Henry L Henderson to Levy the sum of Four
 hundred and forty one Dollars & 41/100 Damage and cost I have
 seized and taken of the lands and tenements of the said Henry
 L Henderson all that certain piece parcel and tract of land
 containing One Hundred and twelve more or less, acres
 situate and being in the District of Greenville adjoining lands
 of Widow Moore James Locke and others, and whereas the
 said premises with their appurtenances since the seizure by
 me made by virtue of the said writ of Fieri Facias before
 mentioned have been exposed to sale at public vendue and
 purchased by Henry Baldwin of the District of Greenville
 for the sum of three Hundred and one dollar being the highest
 sum that was bidde therefor, Now know ye that I John J
 McDaniel Sheriff aforesaid by virtue of the said writ of Fieri Facias
 aforesaid to me directed and delivered as aforesaid and by virtue
 of the Statute in such cases made and provided and for and in
 consideration of the said sum of three Hundred and one dollars
 to me in hand paid, or secured to be paid by the said Henry
 Baldwin the receipt and payment whereof I do hereby acknow-
 ledge have granted bargained and sold and by these presents
 do grant bargain and sell unto the said Henry Baldwin
 his heirs and assigns forever the said tract piece and parcel
 of land with its appurtenances, and all the estate right title
 and interest which the said Henry L Henderson of right had
 of, in and to the same, To have and to hold the said piece parcel
 and tract of land with its appurtenances unto the said Henry
 Baldwin his heirs and assigns forever as fully and absolutely
 as I the said John J McDaniel might could or ought to grant
 bargain and sell the same by virtue of the Statute aforesaid
