McMillen for and in consideration of the sum of three hundred dollars to me in hand paid by Isaac Hicks of the State and District aforesaid have granted bargain sold and released and by these presents do grant bargain sell and release unto the said Isaac Hicks all that tract or parcel of land situate in the District and State aforesaid on branchy waters of Enore River the same a part of a tract of a track known as the Isaac Taylor Land containing seventy eight acres more or less beginning at a Post oak 3x and running N 72° E 250 chs to a post in a road leading from Samuel Gibsons to J. M. Crotwells thence N 78° E 350 chs to a stake point in said road thence East 75 chs to a stone in the road thence N 64 1/4° E 14.90 chs to a point in road thence S 60° E 16.88 chs to a Pine stump on a branch thence S 51 1/2° W 57.90 chs to a Hickory 3x on thence N 54 1/2° W 8.50 chs to a Poplar 3x and thence up the meanders of the branch about 17.20 chs to a stone on the Bank of Branch thence up the Edge of the Swamp to the beginning. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the premises above mentioned unto the Isaac Hicks his heirs and assigns forever. I do hereby bind my self my heirs Executors and administrators to warrant and forever defend the premises above mentioned unto the said Isaac Hicks his heirs and assigns and every other person or persons lawfully claiming or to claim the same or any part thereof.
