George Mc Chaplin	Deed	The State of South Carolina know all men by these presents that I George Mc Chaplin of Greenville District in the State aforesaid for and in consid- -eration of the sum of Two thousand Dollars to me paid by Isaac Brown of Charleston in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Isaac Brown all that piece parcel and lot of land situate lying and being within the corporate limits of the Town of Greenville in the State aforesaid, and upon the west side of Richard- -son Street and bounded as follows. To wit, on the East one hundred and three feet by Richardson Street aforesaid, on the North three hun- -dred and fifty feet by Lots of W. H. Harrison and Mrs Caroline Maul- -din on the west one hundred and three feet by land of Vardney Mc Bee and on the South three hundred and fifty feet by lots of P West and Mrs Waddale being the same Lot conveyed to me by C J Elford by deed bearing date the first day of January one thousand eight hundred and sixty one. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining To have and to hold all and singular the said premises before- mentioned unto the said Isaac Brown his heirs and assigns for ever and I do hereby bind my self my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Isaac Brown his heirs and assigns against me and my heirs and against every other person whom- -soever lawfully claiming or to claim the same or any part thereof Witness my hand and seal this Twenty first day of November in the year of our Lord one thousand eight hundred and sixty two and in the Eighty seventh year of the Sovereignty and Independence of the State of South Carolina Signed Sealed and delivered in the presence of Preston West J L Donaldson
