 bargained sold released and conveyed and by these presents  
 do grant bargain sell release and convey unto the said  
 Robert J Vaughan a certain piece of land in the State and  
 district aforesaid on the water of Clear Creek a branch  
 of South Syger River it being a part of a tract of land owned  
 by my father Cornelius Stewart, and bounded as follows  
 beginning on a Poplar near Mary Stewarts Spring thence  
 nearly north to a white oak on the branch which divides it  
 from Mary Stewarts land, thence up the meanders of the  
 branch to Thomas Chandlers line thence with Chandlers line  
 S20 E to a stone corner thence S87 E 11.25 chs to a stone thence  
 S65 E to a stone thence nearly north to a poplar at the head  
 of a draw thence with the draw to a stone corner in the  
 field nearly east of Mary Stewarts Spring thence S82 W  
 about 3 chs to a poplar the beginning corner containing fifty  
 acres more or less. So have and to hold the above granted
