 died before his mother, said tract of land then became the  
 property of George W Center and Lydia Ann Barton formerly  
 the wife of the said Jesse K Center and now the wife of Charrow  
 Barton. Know ye that I Charrow Barton and Lydia Ann Barton  
 wife - of Greenville District and State aforesaid for and in considera-  
 - tion of One dollar to us in hand paid by Georg Center of Greenville  
 District and State aforesaid have granted bargained sold and  
 released and by these presents do grant bargain sell and release  
 unto the said George W Center all our right titles interest and  
 inheritance in a certain part of the above named tract of  
 Land situate in Greenville District and State aforesaid on  
 Branch waters of Middle Tyger River and bounded as follows  
 Viz. Beginning at a Persimmon 3+ at the head of a hollow and  
 runs Westward to a stand at Joseph Bartons fence, thence with  
 said fence a S E course to a Stone, thence near East course with  
 Bartons line to a Chestnut, thence about a South course to a  
 Black Oak at a branch, thence a S. E course with G W Centers  
 line to a Stone on the Road leading to Gassy Mountain Church  
 thence with said road to a Stone near the Gran yard, thence S 7 1/2  
 W 11.25 to a Stone 3+ thence N 83 W 5.35 to a Stone 3+ near a 3  
 prong Chestnut Oak thence S 67 W 23.25 to the beginning - containing  
 by estimation One hundred acres more or less, Together with all  
 and singular the rights members hereditaments and appertenan-  
 - ces to the said premises belonging or in any wise incident or  
 appertaining, To have and to hold all and singular the said  
 premises unto the said George W Center his heirs and assigns  
 for ever, And we do hereby bind ourselves our heirs & executors  
 and administrators to warrant and forever defend all and
