 thence S 84 W along a line run for M Linsey now J Gosnell
 line to a Hickory thence S 9 W 8.50 lks to Oak thence S 40 E 11.50
 lks to a chestnut on the Bank of the creek thence down said
 creek 5 chs 50 lks to the junction of the Cove Branch & thence
 up S. D branch to the beginning corner by Estimation forty
 acres more or less unto the said Joseph Burrill his heirs &
 assigns forever I do hereby bind my self my heirs Executors
 & administrators to warrant & forever defend the said
 farm I cis unto the said Joseph Burrill his heirs &
 assigns forever against my self my heirs executors admin-
