District in the State aforesaid in consideration of the sum of Forty Seven hundred & Sixty dollars to me paid by Thomas C Markely in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Thomas C Markely all that tract of land situated lying and being in Greenville District containing Two hundred and thirty eight acres be the same more or less bettering and bounding as follows to wit, beginning at a stake below a large Rock formerly a white oak 3+ Running thence N 44.50 to a stake on a ditch line to a Willow 3+ thence along a Ditch line to a black gum 3+ thence N 80 W 30.50 to a small Post oak 3+ thence S 17 E 13 25 thence on Wilson Ferry road line S 13 E 42.50 to a stake thence E 19 to a Pine thence N to a small Post oak thence S 56 E 9 30 to a hickory 3+ thence N 15 W 11 to the branch thence with the meanders of said branch to a stake the beginning corner the said tract of land was conveyed to me by W J Gantt deed bearing date the tenth day of June 1844, bounded by lands of Judge Gantt & Cleveland W Benson and others. the same being composed of two different tracts of Land, the one conveyed by Douglas Holloway to Judge Gantt by deed bearing date 11th of July 1827 the other tract conveyed by Thomas Crawford to Richard Gantt by deed bearing date the 7th July 1826 both tracts were conveyed by Richard Gantt by one deed to W J Gantt bearing date 25th of December 1833 the whole together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Thomas C Markely his heirs and assigns forever, and I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said Thomas C Markely his heirs and assigns against me and my heirs lawfully claiming or to claim the same or any part thereof. Witness my hand and seal this sixth day of November in the year of our Lord one thousand eight hundred and sixty three and in the eighty eighth year of the State of South Carolina.
