 tract of land of Elijah Pike Sen deceased containing one
 hundred and twenty five acres more or less, beginning at a
 Stake 3 + Jones corner and running thence N 62 E 32.45 to a
 Stake 3 + new thence S 29 W 37.14 chs to a Sassafras 3 + thence
 S 29 1/2 down the meanders of a branch to a White oak 3 + thence
 N 2.40 to a Black Gum 3 + new thence S 61 W 25.75 chs to a Stake
 3 + new thence S 33 E 36.70 chs to the beginning, about, one quarter
 acre as shown on the plat hereunto annexed being reserved
