David C Lester	Land	that I Anna Langley of the State and District of aforesaid for the consideration of the sum of three hundred dollars to be paid in three annual payments have bargained and sold to David C Lester one half of a certain tract of land and mill situated on the waters of Syger River in the State and District aforesaid beginning on a red oak & thence N 82 W 6 chains 25 L to a chestnut & thence N 61 W 15 chs 75 L to a hickory & thence S 8 W 5 chs & 25 L to a poplar & thence S 55 E 5 chs to a black oak & thence to ford of the creek below the mill & thence up the Gully to Simon Lesters line to a stake thence N 8 E to the beginning corner containing twenty five acres be there same more or less, To have and to hold half of the said premises to David C Lester to his heirs and assigns forever and I do hereby bind my self my heirs executors and administrators to warrant and defend half of the above granted premises unto the said David C Lester his heirs and assigns forever against my self and assigns or any other person or persons lawfully claiming any part thereof.
