 Otis Mills all that piece parcel and lot of land situate lying being
 within the corporate limits of the town of Greenville in the District
 & State aforesaid on the East side of Rutherford Street and one mile
 from the Court House containing two acres more or less having the
 following lines, Metes and bounds as represented by a plat attached
 to the deed from Andrew M. McDaniel to myself, beginning at a stake
 on Rutherford Street, Stone corner, & running thence E 24.12 poles
 to a stake thence S 4.6 1 pole to a stake thence W 24.12 poles to
 a stake at Rutherford Street thence with said Rutherford
 Street N 4 W 13 poles to the beginning being the same land conveyed
 by Croft to Goodlett, Goodlett to McDaniel, McDaniel to myself
 by deed bearing date 15th day of October 1863. Together with all
 and singular the Rights Members hereditaments and appurte-
 nances to the said premises belonging or in any wise incident
 or appertaining. To have and to hold all and singular the
 premises before mentioned unto the said Otis Mills his heirs
 and assigns forever and I do hereby bind myself & my heirs
 executors and administrators to warrant and forever defend
 all and singular the said premises unto the said Otis Mills
 his heirs & assigns against me and my heirs and every other
 person whomsoever lawfully claiming, or to claim the same
 or any part thereof or. Witness my hand and seal this 15th day
 of October in the year of our Lord one thousand eight hundred
 and sixty four and in the third year of the Independence of
