E W Hudson Do Tho Steen	Deed For Land	<p style="text-align: right;">937</p> <p>The State of South Carolina Know all men by these presents that I Esli W Hudson of Greenville District and State aforesaid for and in consideration of three hundred and forty two dollars paid to my in hand by Thomas Steen of Greenville District and State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Thomas Steen all that tract or parcel of land situate lying and being in Greenville District and State aforesaid on a small branch of Brushy Creek of Enore River beginning at a small Red oak 37 on the South Side of the Spartanburg Road and runs S 4 1/2 W 48.20 to a Stone 37 thence S 77 1/2 E 14.12 to a Stone 37 in an old field. thence N 16 1/2 E 40.40 to a Stone 37 near the road thence N 88 W 50 links to the beginning containing twenty eight and one half acres more or less. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the said premises unto the said Thomas Steen his heirs and assigns forever And I do hereby bind my self my heirs Executors and administrators to warrant and forever defend all and singular the premises before mentioned unto the said Thomas Steen his heirs and assigns against me and my heirs and against every other person or persons lawfully claiming or to claim the same or any part thereof.</p>
