To J. B. Chaplin J. H. Barnes and Alex. Webb Commissioners of Pulaski County in the State of Arkansas Greeting Know ye that in consideration of your integrity and full power is hereby given to you or to any two or more of you to take probate of the execution of the said decrees annexed from W. P. Passmore of the county of Pulaski and State of Arkansas to Mrs. Melchmina Chapman of the County of Greenville and State of South Carolina dated the 7<sup>th</sup> day of October A.D. 1873 Conveying a certain house and lot or parcel of Land situate lying and being in the County of Greenville in the State of South Carolina on waters of Richland Creek and on both sides of the road leading to Rutherford North Carolina and containing three (3) Acre and one and half acre more or less land bounded as follows Beginning at a Stake on the above Thompson line at the base of the Hill on the South Side of the Creek Running thence North 50 Chas. 50 Links to a Stake near a Spring thence East 50 Links to a Stake thence N 57 1/2 W 650 to a Stake thence near the road thence S 71 1/2 W 5 with the road to a Stake on the old line 30 thence with the old line N 10 E 36 to a P. O. 30 thence W 31 to a Stake thence S 30 W 45 to a Stake thence S 71 E 27 50 to a Stake 30 thence S 70 E 11 to a Stake thence S 45 W 77 to a Stake 30 thence S 40 E 5 to a Stake thence S 6 W 26 9 to a Stake thence S 25 E 11 50 to a Stake 30 thence S 3 E 7 to Thompson line at the base of the Hill thence S 85 E 15 to the base of the Hill thence S 45 E 13 50 to a Stake thence N 55 E 2 to the Beginning For this purpose you shall cause one of the Subscribing witnesses of the said Decree to appear before you & having administered to him an oath or solemn affirmation according to the form of his religious persuasion that his affidavit is true you shall take under his hand an affidavit that he was personally present & saw W. P. Passmore sign seal & deliver the said Decree for the use & intents therein expressed and that he and the other Subscribing witnesses signed their names thereto as witnesses of its execution which affidavit authenticated under your hand & seals you shall annex to said Decree and having certified under your hand & seals the due execution of this writ & verified the same by the oath of you before some officer who is authorized by the laws of your State to administer an oath and whose official signature may be properly authenticated you shall comply therewith to the Clerk of the Court of Common Pleas and General Sessions for Greenville County in the State aforesaid to be duly recorded & manifested
