Know all men by these presents that Perry W Glenn of Greenville County in the State aforesaid in consideration of the sum of One hundred and Ninety Dollars to me in hand paid by Varday M Threlkeld of Greenville County in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Varday M Threlkeld One Black Mare One Cow One Horse Waggon Two Cows and Calves Horse Hold and Kitchen Furniture which I have in Greenville County in the State aforesaid together with all and singular the rights members appurtenances and appurtenances to the said premises belonging or in anywise incident or appurtenancing To have and to hold all and singular the said Black Mare One Cow One Horse Waggon Two Cows and Calves Horses hold and Kitchen Furniture unto the said Varday M Threlkeld his heirs and assigns forever and I do hereby bind myself my heirs Executors and administrators to warrant forever defend all and singular the said Black Mare One Cow One Horse Waggon Two Cows and Calves Horse Hold and Kitchen Furniture unto the said Varday M Threlkeld his heirs and assigns against myself and my heirs and against every person or persons who shall ever lawfully claim or claim the same or any part thereof I witness my hand and seal this fourth day of September in the year of our Lord One thousand eight hundred and seventy five and in the One hundredth year of sovereignty and independence of the United States of America
