"Greeting" Know ye that in consideration of your integrity and skill full power is hereby given to you to take the renunciation of Mrs Mary McRae wife of Vardny A McRae of Lincoln County in the State of North Carolina of her dower in the premises described in the deed from the said Vardny A McRae and Malinda P McRae to William Goldsmith dated at Greenville S.C. the sixth day of November 1875 conveying a certain lot of land situated in the City of Greenville State of South Carolina and bounded by Coffee Spring North and Brown Streets and known of late as McRae Acres lot. For this purpose you will cause the said Mrs Mary McRae to appear before you, and you will examine her privately and separately apart from all other persons, and if upon such examination she shall freely declare that she does freely voluntarily and without any compulsion dread or fear of any person or persons whomsoever renounce release and forever relinquish unto Wm Goldsmith his heirs and assigns all her interest and Estate and also all her right and claim of dower of in or to all and singular the premises described and conveyed in the deed aforesaid. Then you shall take under her hand a certificate of her renunciation as aforesaid in the form of a declaration upon private examination as aforesaid which certificate authorized by your hands and seals now shall remain to the writ

And having certified under your hands and seals the Execution of this writ and verified the same by the oath of one of you before some magistracy who is authorized by laws of your State to administer an oath and whose official signature may be properly authenticated, you shall carefully return this writ together with your proceeding thereon to the Clerk of the Court of Common Pleas and general Sessions for Greenville County in the State first aforesaid to be duly recorded.
