State aforesaid in consideration of the sum of Six hundred and fifty five and 3/100 Dollars to me paid by Henry Springfield Esq. of Greenville County and in the State aforesaid, have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said Henry Springfield Esq. two certain lots of lands situate in the town of Marietta, in Greenville County and the State aforesaid on or near Saluda River Lot No 1 containing two acres and thirty two poles (beginning) at a stake 3x nm on main Street, thence S 19 W 4.00 chs to a stake 3x nm on said Street, thence S 71 E 5.50 chs to stake 3x nm on Burns Street, thence N 19 E 4.00 chs to a stake 3x nm on said Burns Street thence S 71 W 5.50 chs to the Beginning corner Lot No 2 containing three acres one Arod and nineteen Poles, (beginning) at a stake 3x nm on Harriet Bates corner on said Main Street thence S 64 1/2 E 5.40 chs to stake 3x nm on said Burns Street, thence N 19 E 6.40 1/2 chs to a stake 3x nm on said Burns Street, thence N 71 W 5.50 chs to a stake 3x nm on said Main Street, thence S 19 W 5.78 chs to Beginning corner Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, To have and to hold all and singular the premises before mentioned unto the said Henry Springfield his heirs and assigns forever. and I do hereby bind myself my heirs executors and administrators, to warrant and forever defend all and singular the said premises unto the said Henry Springfield his heirs and assigns, against me and my heirs and assigns and any person or persons lawfully claiming, or to claim the same, or any part thereof
