 have granted bargained sold and released and by these presents
 do grant bargain sell and release unto the said Batharine Thinsley
 a certain piece parcel or tract of land containing sixty eight
 (68) acres more or less situate being and lying near the Village of
 Marietta, in Greenville County and State aforesaid, on branches
 of Beaver Dam Creek of North Saluda River and having the fol-
 lowing bounds to wit: Beginning at a Red Oak 3x dead per stake
