ing seventy six acres bounded by my own lands and land of Augustus
Heuff it being a portion of the tract of land deeded to P.D. Heuff

Heuff and then conveyed to me by Jas. W. Heuff Together with all
and singular the rights members hereditaments and appurtenances to
