aforsaid in consideration of two hundred Dollars to me paid by A J Stokes of Greenville County and State aforsaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said A J Stokes all that tract or parcel of land situate in Greenville County and State aforsaid on a small branch of McCalls Beaverdam Creek and between the Rutherford and Jordan Roads, Beginning at a stone on the Rutherford Road and running S 62 E 35.40 to a stone 3+ on the Jordan Road thence up said Road 24.00 chains to a stone 3+ thence N 49 1/2 W 18.30 to a stone 3+ on the Rutherford Road, thence down said Road 25.12 chains to the beginning, containing fifty acres more or less. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said A J Stokes his heirs and assigns forever. And I do hereby bind myself my heirs executors and administrators, to warrant and forever defend all and singular the said premises unto the said A J Stokes his heirs and assigns against me and my heirs and every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof
