J. O. Jefferson Wood merchant doing business in the Town of Cross in the County & State aforesaid in my own name am largely indebted to divers creditors and have become and am unable to pay such indebtedness in full, and whereas in order to have my debts collected and faithfully applied in and towards the payment of my said debts, I have concluded to execute these presents, Wherefore, know ye that in consideration

of the premises aforesaid, and also in consideration of the sum of One dollar to me paid by Simon Hughes of the County and State aforesaid, at and before the sealing of these presents, I do Grant bargain sell and release to and for the uses and purposes hereinafter written unto the said Simon Hughes all my property of every kind whatsoever (except my house hold & kitchen furniture which is not to exceed in amount the amount exempt by Law) consisting of all my stock of goods, chattels, and merchandise with all notes, books accounts and choses in action of every description & kind whatsoever, To have and to hold the said property unto the said Simon Hughes his successors and assigns in trust for the following uses and purposes, First, that is to say - to sell the said stock at private or public sale - according to his discretion upon such terms as he may deem best - to collect and receive all moneys due on notes & accounts, And to pay out from the moneys collected, and that may be received from the sale of the said stock of goods as aforesaid, 1<sup>st</sup> All taxes due the State and County for the year 1880, 2<sup>nd</sup> all existing liens against the said property in the order of their priority, 3<sup>rd</sup> cost and expenses of this assignment, 4<sup>th</sup> Note of J. J. Wood bearing date January the 1<sup>st</sup> 1880 for the sum of twenty seven Dollars due one day after date, - Note given to J. J. & J. Wood, Executors of Baham Wood dead, bearing date January 1 1878 for the sum of one hundred sixty one & 70/100 Dollars due one day after date Note given to J. J. & J. Wood, Executors of Baham Wood dead, bearing date the 25<sup>th</sup> day of Nov. 1878, for the sum of one hundred & sixty three Dollars, due one day after date also one other note given to J. J. & J. Wood Executors of Baham Wood dead bearing date the 6<sup>th</sup> day of January 1881 for the sum of Twenty two & 70/100 Dollars, for a better description refer to said notes, also note due to S. J. Hendrix bearing date the 25<sup>th</sup> day of Nov 1878 for the sum of fifty five Dollars due one day after date, 5<sup>th</sup> After making payment in the above order of the debts above mentioned, with all interest that may due thereon, to pay out all the remainder of said moneys in suitable proportions to all creditors
