containing fifty one acres more or less
together with all and singular the rights
remainders hereditaments and appurtenances
to the said premises belonging or in
anywise appertaining To have and to hold
all and singular the premises before mentioned
unto the said Robt Bryson Sen Robt Bryson Jr
and J L Bryson their heirs and assigns forever
And I do hereby bind myself my heirs executors
assigns and administrators to warrant
and forever defend all and singular the said
premises unto the said Robt Bryson Sen Robt
Bryson Jr and J L Bryson their heirs and

persons lawfully claiming or to claim the
same or any part thereof
