I Emma C McGe of the State & County aforesaid for and in consideration of the sum of Two Hundred Dollars & other valuable consideration to me paid by James M McGe of Greenville County & State aforesaid, have granted bargained and sold and by these presents do grant bargain sell and release unto the said James M McGe his heirs & assigns the following lots in the City of Greenville S.C. to wit: all that piece parcel and lot on Pendleton Street on which is a store house, being thirty three & three fourths feet front and one hundred feet back, as deeded me by Mrs C. A. McKay in January 1874 & that house & lot fronting on Augusta Street known as the house-lead of John McKay deceased containing Seventy four one hundredths of one acre more or less & running back to lands of Furman University & also that lot known as No 4 adjoining lots of L. Williams L. D. Colvin No 9 and Furman University lot and containing sixty four one hundredths of one acre more or less. Together with all singular the rights and appurtenances to the said lots & buildings thereon. Do have & to hold all and singular the premises above mentioned unto the said James M McGe his heirs and assigns forever, and I do hereby bind myself my heirs executors & assigns unto the said James M McGe his heirs and assigns against me my heirs & executors and any person or persons whomsoever lawfully claiming the same or any part thereof.

Caldwell of the County of Spartanburg in the State aforesaid, have granted bargained, sold and released and by these presents do grant bargain sell and release unto the said F. L.
