Center deceased in the State aforesaid, County of Greenville in consideration of the sum of Twenty seven Dollars and fifty cents to me paid by Perry Moore in the State aforesaid Greenville County have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said Perry Moore all my right title and interest legal or equitable, and also all my claim of dower in and to the following described real estate to wit: all that piece parcel and tract of land situate and being in Greenville County on branch waters of Middle Syger River beginning on James Howards Stone corner on the Greenville Road near the Center spring; thence eastward with said road to the Glassy Mountain Church house lot line - thence Southward with said line to a stone corner being the Church lot and Joseph Dallows corner; thence with said Dallows line Southward

Fishers corner, thence westward with the meanderings of said Branch to a white oak being P. & Chastens corner and thence northward with said Chastens line to a white oak the said Chastens corner thence Southward with the said Chastens to a black oak; thence west with said Chastens line to James Howards Chestnut corner on the aforesaid line thence Northward with the said James Howards line to the beginning corner containing fifty acres more or less and the same tract conveyed by J. D.
