 sold and released and by these presents do grant
 bargain sell and release unto L. D. McMakin a
 certain tract piece or parcel of land lying and being
 in the State and County aforesaid on both sides of
 the Portersburg Beaverdam Creek Branch waters of
 middle Sugar River and bounded by lands of J. B.
 McMakin, D. H. Corain and others and runs as fol-
 lows Beginning on a stone st on Dennis Corain's
 line a conditional corner thence a strait line across
 the creek to L. D. McMakin's line thence S 42 50 to
 a stone st on the side of the Bluff thence N along
 J. B. McMakin's line to a stone st P. O. corner thence
 N 89 74 with Dennis Corain's line to the
