 on John Street (South side) in the City of Greenville
 and having the following lines, metes and bounds,
 to-wit: Beginning in the Corner of lot conveyed by me
 to Belton Gilreath, and running thence N. 27° E. to pin
 in the line on South side of John Street, thence S 45° E.
 with said John Street to corner of said Gil-
 reath lot; thence S. 27° W. 56 feet with said Gilreath line to
 iron pin thence N. 60° W. about 72 feet to the beginning cor-
 ner, together with all and singular the Rights, Mem-
 bers, Hereditaments and appurtenances to the said Prem-
 ises belonging, or in anywise incident or appertaining,
 to have and to hold, all and singular the said Premises
 before mentioned unto the said George W. Marshall, his Heirs
