And I the said Yancy Clinch scales for myself and my heirs Executors and Administrators do covenant Promise Grant and Agree to and with the said W. P. Willis his heirs and assigns by these Presents in manner and form following, that is to say, that I the said Yancy Clinch scales am now at the time of the sealing and delivering of these Presents lawfully and absolutely seized of and in the said lot of land and all and singular other the Premises hereinbefore mentioned, and intended to be hereby granted and released, and every part and parcel thereof with their and every of their appurtenances, of a good, true, perfect and absolute state of Inheritance, in Fee simple, without any manner of condition, trust, Power of Reservation or limitation or any use or uses, or other restraint matter or thing whatsoever, to alter, change, alter, defeat, or enjoin the same. And also, that I the said Yancy Clinch scales now have in myself good right full power and lawful and absolute a the full grant release and confer to the said W. P. Willis,

and all and singular other the premises hereinbefore mentioned, and intended to be hereby granted and released, and every part and parcel thereof with their and every of their appurtenances, unto the said W. P. Willis, his and assigns forever as aforesaid. And also, that it shall and may be lawful to and for the said W. P. Willis his heirs and assigns from time to time, and at all times, forever hereafter, peaceably and quietly to enter into, have, hold, occupy, possess and enjoy the said lot of land herein sold and granted and all and singular other the Premises hereinbefore mentioned and intended to be hereby granted and released, and every part and parcel thereof with their and every of their appurtenances, without any of the lawful Let, Suit, Trouble, molestation, Eviction or interruption of me the said Yancy Clinch scales my Executor, or Administrator, or any other person or persons whatsoever. And that free and clear, and perfectly and clearly, and absolutely, ungranted, unencumbered and discharged of, and from all and all manner of fortunes and other gifts, Grants, Bargains, Sales, Leas, Hells, Lents, jointers, Dowers, judgments, Executions, Charges and Incumbrances whatsoever, had, made, done, committed or suffered by me the said Yancy Clinch scales or any other person or persons whatsoever. And Lastly, that I the said Yancy Clinch scales and my heirs, and all and every other person or persons lawfully claiming or to claim, any Estate Right, title, trust, or Interest, of in or to, the said lot of land and all and singular other the Premises hereinbefore mentioned, and intended to be hereby granted and released, or any part or parcel thereof, shall and will, from and at all times hereafter, at the reasonable request, and profit, Costs and Charges of the Law, of the said W. P. Willis or his heirs and assigns, make, do acknowledge and execute, or cause and procure to be made, done, acknowledged and executed, all and every such further and other lawful and reasonable Act and Acts, thing and things, Conveyances and assurances in the Land whatsoever for the further, better, and more perfect and absolute granting, conveying and assigning the said W. P. Willis and all and singular other the Premises hereinbefore mentioned and intended to be hereby granted and released, and every part and parcel thereof with their and every of their appurtenances, to and for the use and benefit of the said W. P. Willis his heirs and assigns forever.
