assigns all that piece parcel and lot of land situate lying and being in the City County and State aforesaid, beginning at a point on my line thirty feet from the center of Hudson Alley where same intersects my said line and running thence S 69° 11' E 32.8 feet to an angle point, thence S 35° 30' E 52.2 feet to Broad Street thence along the outer line of Broad Street 40 feet, thence N 35° 30' W 52.2 feet to an angle point, thence N 69° 11' W 32.8 feet to my line and thence with my line to the beginning the same being a sixty foot street known as Webster Street and adjoining and containing Hudson Alley to Broad Street, and conveyed to said City for street purposes and use, and upon condition that said City shall receive the same and keep it in good passable order for travel, and upon the further condition that should the outlet of the sewer pipes laid in said street become a nuisance to said City shall by its proper authority, cause said outlet to be located at a point lower down Reedy River.
