River about four miles north of the City of Greenville containing eight
four acres more or less and adjoining lands of W. C. Cleveland John
Davidson and lands known as the Thompson lands and lands of
E. H. Hunt.

belonging, or in anywise incident or appertaining; and all the estate, right, title, claim, and interest whatsoever, of the
