the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these presents DO GRANT, bargain, sell, and release unto the said *Sallie Halliday* all that *piece* parcel or tract of land situate, lying and being in the County, and State aforesaid in *Dunklin* township, containing *fifty seven* $9 \frac{1}{2}$ (57 $\frac{1}{2}$) acres, more or less, and having the following courses and distances: Beginning at a stone corner 34.00, thence N10W 20.00 to a stone 34.00, thence S83W 28.90 to a stone 34.00, thence S7 1/2 E 20.00 to a stone 34.00, thence N83 E 28.50 to the beginning corner, and bounded by lands of *Wells Seaborn James Scott, E.
