(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Dr G W Wasson, all that piece or parcel of land, situate and being in the State and County aforesaid in Fairview Township on waters of South Babson Creek waters of Reedy River adjoining lands of the said Dr G W Wasson G W Brownlee and the estate of Mrs E D Perry beginning at a stone 37 on Fairview Church road, thence N 1/4 W 21.58 to stone 37 on Wasson, thence S 73 1/2 E 7.85 to point in the ridge road, thence along said road S 18 1/2 E 9.00 to a point, thence S 12 1/2 E 3.21 to black oak 37, thence S 36 W 11.35 to the beginning corner, and containing four and sixty seven one hundredths acres, more or less,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.
