Cowart, All that piece, parcel or lot of land, in the County of Greenville, State aforesaid, having the following metes and bounds, to wit: BEGINNING at an iron pin on Augusta Street, J.E. Lewis' corner, and running thence with J.E. Lewis' line S. 28 3/4 W. 12.76 chains to an iron pin; thence continuing with J.E. Lewis' line S. 28 3/4 W. 12.76 chains to an iron pin on R.H. Earle's line; thence with said Earle's line N 46 1/2 W. 4.44 chains to Wilsons Bridge Road; thence with said road N 26 1/2 E. 14.96 chains to a stake; thence continuing along said road N. 17 3/4 E. 7.50 chains to a stake in a ditch, O.P.
