(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert L. McGee and his heirs all that certain lot or parcel of land, situate lying and being in the City of Greenville in the County of Greenville in the State of South Carolina having the following metes and bounds to wit; Beginning at a stake X on Vardry Street and running thence N. 74 W. one hundred & eighty (180) feet to stake 3x on corner of Vardry and Anderson Streets thence S. 30 1/2 W. along said Anderson Street two hundred (200) feet to a stake 3x at corner of lot sold to Chas. B. Blackwelder by Mrs. Harriett E. Stradley thence along line of last mentioned lot S. 75 1/2 E. One hundred and eighty (180) feet to a stake thence N. 26 1/4 E. two hundred (200) feet to beginning corner. Being the same lot of land conveyed me by Mrs. Harriett E.
