THIRTEENTH: All that piece, parcel or lot of land situate, lying and being in the fourth ward of the City of Greenville in the County of Greenville and State of South Carolina, on James Field's line and being a portion of the lot conveyed to James Fields on January 31, 1888 and by him conveyed to Harriet Pope by deed dated August 6, 1890, Book V.V. Page 841 and having the following metes and bounds, to wit: Beginning on Court Street on James Field's line and running thence East on Court Street, thirty seven feet and eleven inches, thence N. seventy two feet and six inches to McBee's spring lot; thence West thirty seven feet to James Field's corner; thence South Seventy four feet to the beginning corner on Court Street.
