Bishop, all that parcel, piece, and tract of land situated in Butler Township Greenville C. about eight miles South-east of Greenville City, adjoining Lands of Thomas Sheppard, Mr. Knight Henry Jones and others, and having the following metes and bounds; Beginning at a stone Sheppard and Lanford corner; thence N. 22 3/8 E. 23.57 to stone 3 x om; thence N. 40 3/4 W. 22.20 to stone on East bank of Little-Rockey Creek; thence up and with the meandering of said creek to stone corner on same side of creek 3 x om; thence S. 43 1/2 E. 28.75 to the beginning corner, containing fifty-four and twenty one hundredths acres, more or less

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said W.D. Bishop, and his Heirs and Assigns forever.
