Cureton of the town of Greers, South Carolina

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Geo D. Cureton all that certain piece, parcel and lot of land situated, lying and being in the town of Greers, County of Greenville, and State aforesaid, ; beginning at an iron spike on the South side of Emma street, the Baptist Parsonage lot corner, and runs; thence with Emma street eighty (80) feet to an iron spike, corner of new street (not named); thence with new street two hundred and three (203) feet to an iron spike; thence S.E. eighty (80) feet to an iron spike, corner Baptist Parsonage lot; thence with Parsonage line two hundred and three (203) feet to the beginning corner, and containing sixteen thousand two hundred and forty square (16,240) feet and bounded on the North by Emma street on the east by Parsonage lot on the West by new street not named and on the South by lands of Mrs. E. A. Westmoreland.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said George D. Cureton, his Heirs and Assigns forever

And I, do hereby bind my-self my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said George D. Cureton, his
